Transitioning from ISO 9001:2008 to ISO 9001:2015

ISO 9001:2008 has been revised; replaced with ISO 9001:2015. Gone are the five sections that described the requirements. In their place are seven sections. Many of the "old" requirements remain, some are gone, some are changed and some new ones have been added. So, if you are already certified to ISO 9001:2008, or even if you are considering becoming certified to either ISO 9001:2008 or ISO 9001:2015, this seminar is for you. (NOTE: The two versions of ISO 9001 overlap until 9/15/2018, however, organizations are strongly encouraged to make the change to the 2015 version no later than the end of 2017.)

A comprehensive review of the requirements will be provided, including several tools that you will find valuable as you move toward implementation of the changes. These tools include a document that will enable you to assess your current situation against the new requirements and tools for dealing with the new requirement for risk management. Group exercises will allow you to benefit from the experiences of other organizations.
